



## 2025 Community Service Award

### Criteria

This award is intended to recognize employees of ACEC Colorado member firms for their accomplishments in community service.

**1. Nominations:** Any member of ACEC Colorado is eligible to apply.

- Nominations are due to ACEC Colorado by 11:59pm **Friday, March 14, 2025** and submitted electronically to [email@acec-co.org](mailto:email@acec-co.org).

**2. Evaluation and Selection of Nominees:**

- The evaluation of the nominees for the award will be made by the ACEC Colorado Foundation Education & Workforce Development Outreach Committee. Judges will independently review and score each submission then convene to combine all scores.
- The ACEC Colorado 2025 recipient will be submitted to ACEC National. The evaluation of the nominees for the award will be made by the Community Service Awards Subcommittee of the Fellows Committee. The Subcommittee will recommend the top nominees to the Fellows Committee.

**3. Criteria for Award:**

- *The nominees shall be outstanding individuals who have been involved in community service such as board, commissions or community groups and shall have demonstrated a sustained commitment to their communities.*
- The nominees shall be perceived by the public in their communities as leaders. The nominees may have been active in local, county or state government.
- The nominees shall have served to influence decision-making on issues other than professional.
- The nominees may demonstrate, through their civic involvement, how the quality of life in their community has been enhanced.
- The nominees shall have received no remuneration for professional services rendered, if any.
- The nominees shall be or have been a principal or manager in a member firm of ACEC Colorado for at least five (5) years.
- No more than five (5) awards may be given each year.

**4. Recognition:**

- The state recipient will be recognized on April 24 at the ACEC Colorado 2025 Annual Conference at Hotel Polaris at the United States Air Force Academy.
- All winners will be recognized in-person during the Awards Luncheon at ACEC's Fall Conference.
