___ **GOVERNMENT AFFAIRS** | Monthly 3:30 p.m. on Third Wednesday
Establishes legislative programs to assist members in meeting their legislators, monitors and enacts recommendations for legislation, works with lobbyist, establishes legislative contact program and informs members about legislation that affects the industry and their work.

___ **MEMBERSHIP** | Monthly 3:30 p.m. on Tuesday Prior to Third Thursday
Advises and participates in programs to recruit and retain members from across the state. Reviews and approves applications for recommendation to the Board of Directors. Establishes contact and communication programs with member firms to encourage all-employee participation in Council programs and offerings.

___ **PUBLIC RELATIONS** | Monthly 1:30 p.m. on Third Tuesday
Provides guidance and serves in an advisory capacity to ACEC Colorado staff on all issues related to engaging member firms through business development (BD) and marketing-communication initiatives—e.g., Colorado's annual Engineering Excellence Awards, Honor Awards, educational offerings for ACEC Colorado Conference, ACEC National BD-MarCom Forum.

___ **VERTICAL/BUILDING DESIGN** | Monthly 11:30 a.m. on First Tuesday
Addresses issues specifically affecting ACEC Colorado-member firms in the vertical design segment of the industry and supports those member firms with information, advocacy and assistance.

___ **TRANSPORTATION** | Bimonthly 11:30 a.m. on Third Wednesday
Assists in establishing and communicating member relationships with transportation agencies, especially Colorado Department of Transportation, to facilitate the exchange of information and ideas. Also, participates in a quarterly meeting with staff from CDOT and assists in developing the agenda for that meeting.

- SUBSURFACE UTILITY ENGINEERING (SUE)** | Ad Hoc Meeting Basis
Committee provides input on SUE-related issues, including the Colorado Underground Damage Prevention Safety Commission's rules and ACEC Colorado's recommendation to Governor for the latter commission's member appointment, per Colorado statute. Establishes liaison relationships with related agencies that include the Office of the State Engineer, Colorado Department of Natural Resources, Colorado Water Conservation Board, Mile High Flood District and Colorado Department of Health & Environment.

___ **ENERGY & CLIMATE STRATEGY** | Monthly 9 a.m. First Friday
Develops industry-wide consensus and leadership positions on issues related to energy production, energy alternatives and climate change important to engineering firms operating in both horizontal and vertical markets; undertakes a proactive legislative and regulatory advocacy program; and communicates with member firms on the energy and climate change issues that affect their businesses.
