This award is intended to recognize the accomplishments of our young professionals who have contributed to the engineering profession and impacted society.

1. Name of Award: ACEC Colorado Young Professional Award

#### 2. Nominations:

- ➤ A nominee shall be employed at a member firm of ACEC Colorado
- Nominations are due to ACEC Colorado by 11:59pm on Friday, March 15, 2024.
- All nominations must be complete and submitted electronically on the nomination form provided. Please submit all applications to Abby Clark at <a href="mailto:abby@acec-co.org">abby@acec-co.org</a>
- Incomplete nomination forms may delay processing and not meet the deadline.

#### 3. Evaluation and Selection of Nominees:

- ✓ The evaluation of the nominees for the award will be made by the ACEC Colorado Board of Directors.
- ✓ The ACEC Colorado 2024 recipient will be submitted to the ACEC National Fellows Committee. The top vote getting national finalist will be announced as the Young Professional of the Year at the annual ACEC National 2024 Fall Conference.

#### 4. Criteria for Award:

- ➤ The nominees shall be employees of ACEC Colorado member firms.
- > The nominees shall be engineers 35 years of age or younger as of Dec. 31, 2024.
- The nominees shall be a registered Professional Engineer, Professional Land Surveyor or hold a professional license in their field of expertise in Colorado.

#### 5. **Recognition:**

- The state recipient will be recognized on April 25 at the ACEC Colorado 2024 Annual Conference at Denver Marriott Westminster.
- The ACEC National finalists will be recognized in person at ACEC National 2024 Fall Conference Awards Luncheon.
- The ACEC National Young Professional of the Year will be announced during the Awards Luncheon at the annual ACEC Fall Conference. The winner will receive a scholarship from the College of Fellows to attend the ACEC Business of Design Consulting seminar.
